MY HORSE IS LEAVING FOR A PERIOD OF GREATER THAN NINE MONTHS

- You need to complete the application for permanent export form ticking the box informing us the horse is being exported permanently, the box requesting the Export Certificate be sent to the country of export and, if you require, the box requesting an Animal Health Act (A.H.A.) Certificate.

MY HORSE IS A BREEDING ANIMAL LEAVING FOR A PERIOD OF LESS THAN NINE MONTHS

- You need to complete the application for temporary export form, ticking the box informing us the horse is being exported temporarily, the box requesting the Breeding Clearance Notification and, if you require, the box requesting an Animal Health Act (A.H.A.) Certificate.

MY HORSE IS A FOAL OR YEARLING AND IS LEAVING FOR A PERIOD OF LESS THAN NINE MONTHS

- You need to contact the Stud Book Department at Weatherbys who will supply you with the correct form for applying for a General Notification of Movement.
- If required, complete the reverse of this form requesting an Animal Health Act (A.H.A.) Certificate.

MY HORSE IS A RACING ANIMAL LEAVING TO RACE FOR ITS CURRENT BRITISH TRAINER

- You need to contact Customer Services on 01933 304808 at Weatherbys to arrange for a Racing Clearance Notification (RCN) to be forwarded to the Foreign Authority.
